

RESOLUTION 2009-07

**A RESOLUTION OF THE BOARD OF DIRECTORS OF
THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT
AMENDING FIXED EMPLOYER'S CONTRIBUTION FOR UNREPRESENTED
PUBLIC EMPLOYEES' MEDICAL AND HOSPITAL CARE ACT**

WHEREAS, the Board of Directors of Rancho Murieta Community Services District has heretofore adopted Resolution No. 84-9 establishing a Fixed Employer's Contribution for Public Employee's Medical and Hospital Care Act; and

WHEREAS, the Board of Directors of Rancho Murieta Community Services District amended the Employer's Contribution amount for said Public Employee's Medical and Hospital Care Act in 1999 by adopting Resolution 99-8;

WHEREAS, the Board of Directors of Rancho Murieta Community Services District amended the Employer's Contribution amount for said Public Employee's Medical and Hospital Care Act in 2004 by adopting Resolution 2004-21;

WHEREAS, Government Code Section 22892(a) provides that a local agency contracting under the Public Employee's Medical and Hospital Care Act shall fix the amount of the employer's contribution at an amount not less than the amount required under Section 22892(b)(1) of the Act; and

WHEREAS, the Board of Directors of Rancho Murieta Community Services District last amended the Employer's Contribution amount for said Public Employee's Medical and Hospital Care Act in 2008 by adopting Resolution 2008-10;

NOW, THEREFORE, the Board of Directors of Rancho Murieta Community Services District resolves that the section of Resolution 2008-10, describing the Employer's Contribution, shall be amended to read as follows:

- B. The employer's contribution for unrepresented employees or annuitants shall be the amount necessary to pay the full costs of his/her enrollment, including the enrollment of his/her family member(s), based on the lowest health benefits plan offered by PERS with respect to unrepresented employees or annuitants enrolled for self alone is \$473.48 per month, for an employee or annuitant enrolled for self and one family member is \$ 946.96 per month, and for an employee or annuitant enrolled for self and two or more family members is \$1231.05 per month, plus administrative fees and Contingency Reserve Fund assessments. The change is effective January 1, 2010 and is reviewed periodically by the Board.
