

ORDINANCE NO. 87-7

AN ORDINANCE OF THE BOARD OF DIRECTORS
OF THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT
AMENDING CHAPTER 5 OF THE DISTRICT CODE
RELATING TO PERSONNEL RULES

BE IT ORDAINED by the Board of Directors of the Rancho Murieta Community Services District as follows:

SECTION ONE:

Section 6.02 of Chapter 5 of the District Code is hereby amended to read:

Section 6.02 Overtime

(b) Employees required to work overtime shall be compensated at one and one-half times their normal hourly wage for each hour worked in excess of their normal work day. Normal work day is defined as eight hours for employees scheduled to work a five day week, ten hours for employees scheduled to work a four day week. Employees required to work more than forty hours in any work week shall be compensated at one and one-half times their normal hourly wage for each hour worked in excess of forty.

(c) Employees required to work on holidays shall be compensated at one and one-half times their normal hourly wage, but such overtime pay shall apply only to the first eight hours so worked.

SECTION TWO:

To the extent that the terms and conditions of this Ordinance may be inconsistent or in conflict with the terms and provisions of any prior District ordinance, resolutions, rules, or regulations, the terms of this Ordinance shall prevail with respect to the terms and provisions thereof and such inconsistent or conflicting terms and provisions of prior ordinances, resolutions, rules and regulations are hereby repealed.

SECTION THREE:

If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, no other provision of this Ordinance shall be affected thereby.

SECTION FOUR:

This Ordinance shall be in full force and effect thirty (30) days after adoption and shall be published no less than once in a newspaper of general circulation published in the District within thirty (30) days after adoption.


